Action Taken Report (ATR) prepared in the IQAC meeting conducted on 07.02.2026

An IQAC meeting was held on 07.02.2026 to review the academic and administrative performance. An Action Taken (ATR) was prepared to specify the steps taken and progress made by the institution in response to the recommendation decided during the previous IQAC meeting which is summarized below.

## 1. Teaching and Learning Enhancement

- Previous resolutions regarding teaching strategies were discussed and amendments were made for further improvement. More stress was laid on presentations, assignments, projects, collages, tests and quizzes.
- Recommendations were made to motivate students to attend regular classes and participate actively in all the programs conducted by the college.

## 2. Stakeholder Feedback Implementation

- Students, faculty and alumni feedback was encouraged and analyzed along with employer's feedback, to foster continuous improvement.
- Resolutions were made to include better faculty training and improve students' support services.

## 3. Faculty Development Program (FDP) and Training

- Faculty members are encouraged to participate in FDPs, Refresher Courses, and Workshops on Indian Knowledge System (IKS), NEP and emerging technologies

## 4. Mentoring and Skill Development for Students

- Students were encouraged to participate in online and offline certificate courses, workshops etc.

- b. Students benefitted from life skills, career and business skills taught in personality development workshops and money management workshops arranged by (SEBI)
- c. Faculty members were encouraged to prepare podcasts, e-content, to support slow learners, and upload on YouTube.

**5. Research and Project Funding**

- a. Faculty members were advised to apply for research grants and project funding to enhance institutional output.

**6. NACC and Academic Performance Monitoring**

- a. Regular review meetings were held with NAAC Committee and IQAC to track progress on the resolution made in previous sessions.

**7. Student Induction & Placement Initiatives**

- a. Orientation Programs were held for first year students to familiarize them with the campus.
- b. Students have been exposed to information regarding various opportunities available to enhance their exposure through financial enhancement programs through (SEBI), NANDI and Mission Shakti.

**8. Student Satisfaction and Performance Improvement**


- a. A student satisfaction survey was conducted to assess areas for improvement in teaching, infrastructure and student services.
- b. Additional remedial sessions and skill development workshops were introduced to enhance student learning outcomes.
- c. Students were also introduced to their duties as citizens of the country, the world and made aware of civic sense and responsibilities.
